Although my schedule as a fulltime minister will be full, it is my hope that I will, on occasion, be able to attend First Parish events with Donna. Another great benefit of my first ministry position being in this area is that Donna and I have one more year to prepare our house for a move and for Donna to continue her ministry at First Parish as your congregational administrator (pending parish approval, of course).

In that past article I also said, "Home congregations are the anchors that allow student ministers to try their wings, knowing a safe place, a sanctuary in every aspect of its meaning, is there for us when we need it." Although I am leaving you again, this time not as a student but as an ordained minister, my feelings regarding home congregations remain the same. I will always feel a connection to First Parish of Sudbury and will be forever grateful for everything I have learned while among you. I sincerely hope that my ministry will provide the same feeling of sanctuary and a vibrant spiritual community for seekers that I have found in Sudbury for so many years. I do know that wherever my ministry takes me over the years, I will always carry First Parish of Sudbury in my heart.

This movie is PG-13, so youth under 13 will need explicit parental approval to attend.

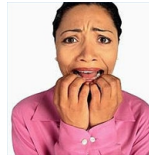

## Background Information Regarding the Proposed Redesign of Sudbury Town Center

For many years, the Town of Sudbury has wanted to redesign the intersection of Concord Road and Route 27. Studies have shown that the intersection has a higher than average rate of accidents. In 2007, the Town proposed several plans that would have constructed a right turn lane southbound on Concord Road. This would have required that at least one lane of pavement would have been "taken" from the front yard of First Parish. At the Congregational Meeting in 2007, the congregation voted against this plan.

The Town of Sudbury has recently presented First Parish with 2 new designs proposed for the Town Center. The Board of Selectman would like to have a review of the plans and select one to take to a detailed design. The review will start at a Selectman's meeting on June 1. Their goal is to present the detailed design at Town Meeting in April of 2011. Both of the plans would require a land transaction with First Parish of Sudbury. As we did in 2007, the Town Center Task Force would like to formalize the opinion of First Parish on the proposed plans based on input received at our Congregational Meeting on June 6, 2010.

The two plans are called the "Offset T" plan, which moves Concord Road to the front of Town Hall, and the "Four Legged" plan, which enlarges the existing intersection. There is a third plan which was proposed by First Parish in 2007 called the "Hybrid" plan. *All three of these plans can be seen on the First Parish website, <http://fpsudbury.org/wiki/TownCenterTaskForce> or go to [www.fpsudbury.org](http://www.fpsudbury.org) and sign in as a Member or Friend, go to Committees, and go to the Town Center Task Force item.*

### SALIENT POINTS PERTAINING TO THE TWO OPTIONS PROPOSED BY THE TOWN OF SUDBURY

#### Concerning both plans:

- Both plans address the traffic flow with safety in mind and not for a reduction in time getting through the intersection.

- Each plan was designed with concrete traffic islands to accommodate light signals on posts, as opposed to massive mast arms (as seen in Wayland Center). One might question which is the worse evil. Or if there can be any other solution.
- Since the plans are preliminary concepts focusing on traffic flow, there has not yet been full consideration of pedestrian access.
- Likewise, access to the town parking lot has not been addressed.

#### Concerning the Offset T Option:

- Grinnell Park with its war memorial and at least one of its Japanese maples would need to be relocated to the enlarged space created next to the Hosmer House. Although it was stated that the expense would not be "that much greater" (only a \$100,000 more than the other proposal), it is a question as to whether there is any money in the budget to do a proper job.
- There will be significant impact on the Minos' property where Concord Rd intersects Route 27
- 20' will be shaved off the front of the First Parish lawn (although this is in the town's Right of Way). The old stone wall would need to be demolished and a new and higher retaining wall built.
- The Meetinghouse will have a greatly extended buffer on its side between it and the new Concord Road. Our driveway will be longer with a few more parking places. There would be significantly more space for the Harvest Fair and other activities.
- F.P will need to transfer approximately 6000 square feet of the Town Common to the Town of Sudbury.
- There are currently 2 lanes of traffic on each side of the Common. This plan would combine them into a stretch of 4 lanes on the far side. That is 47' of continuous pavement. That would require pedestrians to cross 4 lanes coming from the town lot. There would also be 4 lanes in front of First Parish (plus a concrete island) and along the bottom of the Common. The diagonal stretch from the southeast corner of the Common to the entrance to Heritage Park is over 80' of

pavement. This amount of black with white and yellow lines will change the character of the center dramatically from a small New England town to a modernized suburban one. One could argue that is what we are, although most people like Sudbury because of its historic rural character.

- In total, there will be something in the order of 14 traffic poles.

#### **Concerning the 4-Legged Option:**

- 10' will be shaved off the corner of the Hosmer House property, leaving only 5' between the edge of pavement and the corner of the house.
- 11' will be shaved off the front of the First Parish lawn on the Hudson Road side, leaving the stone wall intact – perhaps. Grading may require rebuilding the wall.
- 7' to 9' will come off the side lawn of First Parish on the Concord Road side.
- There will be three lanes of pavement instead of two on Concord Road. And how many on Route 27 ?
- Traffic heading south on Concord Rd and turning left onto Rt. 27 will now have to come all the way to the center to make that turn.
- F.P. will have to transfer 2521 square feet of the Town Common to the town - 8' from the western edge, 5' from its southern edge, effectively shrinking the common.
- In total there will be something in the order of 9 traffic poles.
- Overall, this plan has a smaller intersection than the other option.

#### **Overall considerations:**

*We need to think of what is best for First Parish but also what is best for the safety and character of the town. Will a large stretch of land adjoining our current piece compensate for 4 lanes of traffic? The Wayland meetinghouse has such a property for reference.*

We also need to think of what is historically appropriate. By the records, the original road was the one going by the current town hall. But in our historical memories, having the same general configuration is the way it's "always" been. Which

is more important? It may be of interest that both the Historic Districts Commission and the Historical Commission are dead set against the Offset T.

#### **OTHER OPTIONS**

*Three years ago, First Parish presented its own simplified version to the Town called the Hybrid Option, which merely straightens out the east-west access (Route 27) by shaving off 15' from the front of F.P. lawn, and 11' from the south edge of the common, keeping two lanes on Concord Road southbound.*

Frank Riepe from the Historic Districts Commission has also drawn a plan - also with only 2 lanes along the side of First Parish. Both these lanes would be southbound only, while the two lanes in front of Town Hall would be northbound only. This plan essentially makes the common a very large traffic island. Both of these alternative plans maintain the rural and historic character of the town. It is the Task Force's opinion that these should be considered along with those presented by the Town.

## ...about our guest preacher May 30

Thanks to Jeremiah Gold-Hopton for preaching today while Katie Lee is away from the pulpit. Jeremiah is currently the Intern Minister for Winchester MA Unitarian Society. During the summer of 2009, he was an Intern Chaplain at a hospital in Georgia.

Born and raised in New Jersey, he was a Baptist in early childhood, and became a Quaker when he was ten years old. After graduating from Oberlin College with a B.A. in Biology, he taught English in Japan. After returning to the U.S., he taught science at a school for students with learning differences.

In 1992, he resigned from his teaching position in order to focus on parenting as his primary work, including a few years of home-schooling. His older son Daniel is now a college sophomore, and his younger son Joseph is in 11th grade. In 2006, a Georgia judge finalized the adoptions of Daniel and Joseph by Jeremiah and his spouse Karen. This was the first time that any judge in the United States ruled that a marriage of a transgender person is legally valid and that a transgender person can legally adopt children.

Jeremiah holds a Masters of Divinity degree, and has served in lay positions in the UU congregations. He is now in the ministerial fellowship process.

## ? ? GA 2012 in Arizona ? ?

During a special meeting held May 6, the Unitarian Universalist Association Board of Trustees drafted a resolution to move General Assembly 2012, currently scheduled to be held in Phoenix. The resolution is a response to recently-passed legislation in Arizona that targets undocumented immigrants. The Board's resolution will be voted on by delegates to the 2010 General Assembly when they meet in Minneapolis in late June. A two-thirds majority vote is required to pass the resolution.
